Minutes

I. Call to Order

The College Assembly was called to order by Dean Jo Ann Cruz at 12:40 p.m. on Thursday, November 19, 2009 in Room 332 of Bobet Hall. Attended: A. II. Invocation

Rev. William Farge, S.J., led the invocation.

III. Approval of Minutes

The minutes of October 15, 2009 will be considered at the December assembly.

IV. Guest Presentations

1. Dr. Lydia Voigt, Senior Vice Provost for Academic Affairs

Dean Cruz introduced Dr. Voigt, who said that she would briefly summarize areas for development and refinement by respective task forces, subcommittees or workgroups that she had activated. She discussed the areas of On-line Programs, Evening Division, Common Curriculum, and Graduate Education; she mentioned Summer Sessions, Honors, and Interdisciplinary Minors, as well as offices such as, Study Abroad, Women's Resource Center, and Academic Resource Center. She said that task forces, subcommittees and workgroups would maintain transparency through close communications and updates, regular reports by committee representatives who would also bring back concerns, and launch of web-site presences on the Provost's pages. In response to questions from faculty, Dr. Voigt clarified the following points: summer pricing for 2010 will not change; evening division students may not take on-line versions of available courses; and courses need to be refined and students need preparation before moving on-line. In addition, she said that the evening division currently offers four bachelors degree programs; nursing, criminal justice, liberal studies, and social sciences; and that Loyola anticipates receiving marketing survey results from the Hanover Group to identify needs of non-traditional evening students and to offer additional concentrations. Dean Cruz said that because Q&A time was up, faculty might continue questions to Dr. Voigt via e-mail. Dr. Voigt invited faculty to send her their questions and comments. (Applause.)

2. Mr. John J. Calamia, VP for Finance & Administration

Dean Jo Ann Cruz introduced and welcomed Ms. Adrienne Blanco, Budget Manager, Academic Affairs. She then introduced Mr. Jay Calamia to present finance information to the faculty. Mr. Calamia distributed a handout, "Budget Funds Added for Strategic Initiatives and Other Programs" (attached). He reported operating budget deficits for years 2009 - 2011, with 2012 as the year when sufficient university surpluses are anticipated. He said that the budget and Master Facilities Plan will be presented to the board in December. In reply to a question regarding equity, he said that on December 4 the board is to approve adjustments, and adjustments will be added in successive years until equity is met. Dean Cruz asked him to address the operating budget. Mr. Calamia replied that remaining business interruption insurance had to be used and the board would not go beyond that

amount. He estimated the tuition increase at 5.9%, and salary and equity adjustments at 3.5%. When asked whether choices and decisions to discount summer school (e.g., Xavier's \$200/credit) could be made and what amount went to Student Affairs, he replied that reductions were not anticipated and that none went to Student Affairs' initiatives, although some went to Academic Affairs for Ministry. He added that with regard to choices, for the second year in a row the health insurance premium increases would not be passed on to employees. He anticipated that debt service to fund the Master Plan could approach \$10 million per year, and that the Board would decide in December to fund Phase I. He said that a rebound in market conditions would stop the financial drain; he reported endowment draws at 5% of 3-year moving average, and 2% draw for debt service for the library, or \$4.8 million per year. He said that on-going operations had no additional funds. Dean Cruz suggested that if freshmen enrollments exceed 800, then the operating budget might be given a high priority. Mr. Calamia said that budget was conservatively built to avoid having to adjust salaries downward. A faculty member observed that operatingbudget concerns are from the College Planning Team, along with the request that top priority be given to enhancement of traditional academic programs in order to retain traditional undergraduates. Mr. Calamia said that he had some of the same concerns. As the allotted time had elapsed, Dean Cruz thanked Mr. Calamia. (Applause.)

V. Old Business

- 1. <u>CPT Resolution Inspired by Loyola 2012</u> (Dr. David Moore)
 - Dean Cruz commented that the CPT had decided and Provost Kvet supported the resolution being put through UPT ahead of the budget deadline and prior to any possible vote of the College Assembly, and that Provost Kvet had already used it to increase the academic budget by \$1 million. She said that Mr. Calamia also supported it.

 Dr. David Moore introduced the motion to adopt the resolution given at the October 15, 2009 assembly (attached). The motion was seconded and the question was called. The motion unanimously passed by voice vote, with no opposition and no abstentions.
- 2. <u>Location for Salary Disclosure Data</u> (Dean Jo Ann Cruz)

 "That the College Handbook requires the Dean to make available salary-disclosure data in the Office of the Dean rather than delivering it to the library." Dean Cruz postponed consideration of this resolution until Ms. Gita Bolt, University Counsel, could report at the December 10 Faculty Assembly. The item will be on the December agenda.

VI. New Business

- 1. Indirect Cost Redistribution Recommendation (Dean Jo Ann Cruz)
 - Dean Cruz presented the first reading of the indirect cost redistribution recommendation, distributed at the assembly (copy attached). The resolution was attached to the "Report from the Division of Natural Sciences on the New Policy for Indirect Cost Distribution," electronically distributed to each college assembly member on November 3, 2009 and posted on the college's intranet site.
- 2. <u>Campaign Priorities</u> HNS (Dean Jo Ann Cruz)
 Dean Cruz distributed a handout, "DRAFT Campaign Priorities HNS" (attached) for consideration and comments.

VII. Announcements

- 1. Dean Cruz reported that the winning blog name was "Cruz Lines."
- 2. Dean Cruz said that Dr. Maria Calzada will report on the operating budget.

A Resolution Inspired by Loyola 2012

A Resolution from the Planning Team of the College of Humanities and Natural Sciences to be presented at the October 2009 Meeting of the University Planning Team:

Whereas the University has adopted a thoughtful and outstanding strategic agenda in *Loyola 2012* with academic and mission priorities in the forefront, its current budget cuts and budget structure stand to undermine the academic goals and strategies contained therein. In order to enhance retention through a comprehensive FYE, enable the creative revision of the common curriculum, and move Loyola forward toward enhancing national and international reputation, and climbing in the *U. S. News and World Report* rankings, the top priority for the university must be to enhance its traditional academic programs as the foundation for all strategic goals, objectives, and overarching strategies. Therefore:

Be it resolved that the University prioritize academic investment by increasing the academic operating budgets (working toward restoring the post-Katrina budget cuts), investing in faculty and undergraduate research support, new faculty hires, faculty development and travel, and academic program development.

Be it further resolved that the aforementioned be sent to the University Senate and the University Budget Committee for endorsements.

Indirect Cost Redistribution Recommendation

- The science departments would like the provost to establish a committee on undergraduate research which includes previous successful P.I.'s from the sciences to develop a new indirect cost sharing policy including a description of how funds will be used to support undergraduate research and generate more funded grants.
- 2) We would like the policy to remain 50% to general fund and 50% to P.I. while the new redistribution policy is negotiated.
- 3) The Science division is considering not including Indirect Cost in future grant proposals if a committee of successful P.I.'s is not established to discuss and negotiate a new redistribution policy with the administration.
- 4) In the future, major policy changes which affect undergraduate research should be reviewed by the undergraduate research committee and should be fully vetted by the deans and the faculty.
