OLD BUSINESS

 - i. Academic Actions policy: if you fall into probation, you have to follow up probationary session with a 2.3 semester GPA. Letters will instruct students to follow up with Financial Aid, academic actions are an academic status.
 - ii. Grade Appeal policy
 - iii. Math Placement policy final draft circulated. ALEKS will no longer be used.
 - 1. Will need to be replaced in all DPCL's.
 - 2. Who else needs to be notified that this is a new policy?
 - a. Admissions, New Student Orientation, all Advisors listserv
 - 3. Impact: will remove New Student Orientation need to conduct Math Placement.

 - 1. Will also coordinate with Dr. Ryan to develop the credit hour assessment activity and phase-in plan.
 - b. Academic Integrity policy

 - ii. Have been engaged with this policy for years. Not sure who should manage this policy.

NEW BUSINESS

1. Introduction of Online Student Success Coordinator, Dr. Corina Todoran (Paul Buehler)

- a. Interest in ADC involves policies, especially regarding online students.
- b. Will be important to have someone who knows what the policies for online students should actually be.
- c. First focus is on retention and understanding student experience with online.
- d. Should Dr. Todoran be a regular attendee at ADC? Yes.
- 2. Discussion of Administrative Withdrawal policy (Armin Kargol)
 - a. Students are ceasing to go to class in order to initiate Faculty Initiated Withdrawal.
 - b. Will need to set some guidelines that faculty can use in determining appropriateness and set a deadline for early admin withdrawals and medical excused absences.
 - c. Propose an amendment to the policy: Faculty Initiated Withdrawals can take place up until the last day to Withdraw.
